This will create a unique identifier which is then issued with your badge. If you have already pre-registered at this site you do have to log back in and complete the registration process. Please note we can only issue a badge once the whole process with the Learning Outside the Classroom Council has been completed and you have received an automated email from them informing you of this completed process. Within this inspection the quality standards for risk management are based closely upon the Adventuremark badge. Adventuremark is confined to activity safety (unlike the LOtC Badge it does not explicitly include learning quality) and covers provision to all age groups and covers all activities that are regarded as adventure activities.

Because of the close similarity of the safety standards for each award, AAAC, the Awarding Body for each badge, has decided that LOtC badge holders should be automatically recognised as having also met the standards for Adventuremark. 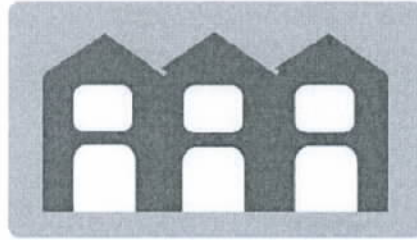

The ending of 1 kayaka session and the start and introduction to another kayaking session. A thorough briefing and safe activity was observed.

Inspector Initials and date of report completion: MST 03 Sep 2010

Overall comments:

The centre has 1 Admin member of staff, 2 Directors and 3 managers all of whom work full time. They also have 2 trainees and 6 seasonal instructors. All qualifications are kept electronically as well as a hard copy. There is a full induction process for new staff and an ongoing monitoring process for staff development and cpd. They have audited fortnightly meetings and review their development and delivery in these meetings.

The management of EOPs/ SOP's is excellent with flow charts in the office and on site at all activity venues. I opened a (randomly selected) sealed first aid kit to check that all phone numbers and details were inside and found this and their operating systems to be simple, safe and effective. When I questioned instructors at activity venues they knew of all medical conditions and knew how to deal with the scenario I posed for them.

This was a very efficient operation and it was refreshing to see an Outdoor provider embracing the use of IT to aid the delivery of activities and for safety processes to be accessible for all to use and monitor.
